### **APD TEST BATTERY**

- There is no GOLD standard for auditory processing testing
- No single assessment tool is sufficient must use battery of tests to confirm or rule out APD condition
- There are many different approaches to assessing auditory processing skills Buffalo Model, Bellis-Ferre Model, Robert Keith's -SCAN.
- Test battery should include:

# **Dichotic Speech Tests**

SSW, Dichotic Digits, Competing Words and Sentences

## **Temporal Processing Tests**

Frequency Pitch Pattern/Duration Pattern/Gaps in Noise

# Monaural Low Redundancy Speech Tests

Low Pass Filtered Words/Time Compressed Words and Sentences/ CID W-22 Words In Noise test/AFG Word test

### MYTHS REGARDING AUDITORY PROCESSING TESTING

- APD testing cannot be performed on children under the age of 7 years. This is false.
   There are several auditory processing tests that are normed and can be administered at a much younger age.
- You must have normal hearing to be a candidate for APD testing. This is false. An
  individual with a milder hearing loss may be tested. There are some tests that are more
  resistant to the effects of hearing loss and others that should not be used (filtered
  speech tests). It becomes more challenging in the interpretation of the results when the
  hearing loss is asymmetrical.
- Only those individuals with an IQ of 85 or above can be tested. This is false. Persons
  whose intelligence is low can often times be evaluated successfully and
  recommendations made to improve auditory processing skills. Determination of
  candidacy should be made on a case-by-case basis.
